Comments on General Meeting – Geof showed Part 1 of his Consumer Electronics Show presentation, which was “great,” and “entertaining and informative.” We had a failure of the video line carrying the presentation directly from Geof’s camera. Our troubleshooting and repair efforts found nothing obvious so this may be due to the camera not being able to drive the signal through the long wire path to the projector. We will test Geof’s camera again in February. It was also suggested that we check ahead of time how a presenter wanted to do their presentation, and check for proper functionality BEFORE the actual presentation.

Gabe indicated APCUG push should start again soon.

Old Business – Gabe and regional computer events: Drawing on his experience with the FACUG cruise, Gabe would like to see FACUG print a handbook for doing a regional event, perhaps leading to something like a Baltimore cruise event. The approximate cost for attendees could be a reasonable \$100 a day. We should consider the benefits of being involved in such an effort.

New Business – The annual elections were held today; the officers are Geof Goodrum as President, Paul Howard as Vice President, Bob Rott as Treasurer and Bill Walsh as Secretary...Calling for Directors in the new year, we had J.Brueggeman, M.Mikosinski, L.Garson, J.Dakin, C.Roberts, and G.Goldberg volunteer to serve; all volunteers were accepted unanimously.
