## **Presidential Bits**

ortunately, good weather prevailed for our March meeting on the last day of winter and we managed to have an excellent turnout for our presentations. Despite problems with the Internet connection, Paul Howard persevered to discuss Roboform (http://www.roboform.com/) to keep track of web site passwords and automate filling online forms, and demonstrate CutePDF Writer (<a href="http://www.cutepdf.com/">http://www.cutepdf.com/</a>) and FoxIT Reader (http://www.foxitsoftware.com/pdf/reader/), free utility programs to create and display/print PDF document files without the size and complexity of Adobe Reader. Chuck Roberts talked about his experiences using the free web-based Secunia, <a href="http://www.secunia.com">http://www.secunia.com</a>, Online scanner and Personal Software Inspector (PSI) application to keep track of software updates on his Windows PC. Chuck ran the Online scanner first, which only checks for updates for a few major applications, then installed PSI on his PC. Although PSI did not recognize all software on his system and kept alerting about updates for some programs that could not be updated, Chuck found Secunia to be a useful program in addition to anti-virus and anti-malware programs to keep his PC software updated with the latest security and bugfixes. Bill Walsh hosted a Learn 30 tutorial session about the difference between 32 and 64 bits, and why this is important in selecting a PC operating system.

We did have enough Internet access to perform the drawings for SandHill Publishing one year magazine subscriptions using the list randomizer feature on the Random.org web site. The winners who weren't present have been notified. See bottom of page 7 for Smart Computing program details...

The April 17th meeting will feature Lorrin Garson's presentation on current readers for electronic books. There are approximately two dozen electronic book readers now on the market. 
#### **GNU/Linux Distribution Releases**

GNU/Linux distributions are bundled collections of software including a set of applications and an operating system built on the Linux kernel. Some distributions include general applications such as office suites, music players, and web browsers, while others may have specific purposes such as computer system recovery, network firewall, media center, or gaming. Individuals, community projects, or businesses create distributions. While some distributions are commercial and include fee-based technical support, other distributions are freely downloadable or can be ordered on CDs or DVD at low cost.

WAC can provide CD-R and DVD±R media for any downloadable GNU/Linux operating system distribution (e.g. Fedora, Mandriva, Ubuntu, Debian, Knoppix). Please note that downloadable distributions do not include official technical support nor printed documentation. Single CD-R discs are available with a \$3 donation; GNU/Linux distributions on multiple CD-Rs or single DVD±R are available with a \$6 donation. Discs are available only by pre-order. Contact Geof Goodrum by e-mail (linux@wacug.org) at least 48 hours before meeting day to order or for more information.

Simon Tatham's Portable Puzzle Collection—r8887. http://www.chiark.greenend.org.uk/~sgtatham/puzzles/. Free MIT License 'C' source code by Simon Tatham. The Portable Puzzle Collection is an assortment of single-player puzzle games. It contains a reimplementation of Minesweeper where every puzzle is guaranteed to be solvable, a number of logic puzzles originally invented by Nikoli, an implementation of Sudoku, and an assortment of other familiar and not-so-familiar puzzle games perfect for energizing your brain during a coffee break.\*

SuperPodder – v1.7. <a href="http://code.google.com/p/superpodder/">http://code.google.com/p/superpodder/</a>. Free Apache License 2.0 Java code by Frank van Lingen. SuperPodder is a lightweight podcast downloader. It features a text based history file that prevents duplicate downloads, a simple XML format for storing your feeds, a simple user interface that gives a detailed overview of download progress, and the ability to specify how many downloads you want from a particular feed. SuperPodder supports RSS feeds containing torrent files.\*

UNetbootin – v419. <a href="http://unetbootin.sourceforge.net/">http://unetbootin.sourceforge.net/</a>. Free GNU General Public License source code and executable by Geza Kovacs. UNetbootin allows you to create bootable Live USB drives for a variety of Linux distributions from Windows or Linux, without requiring you to burn a CD. You can either let it download one of the many distributions supported out-of-the-box for you, or supply your own Linux .iso file if you've already downloaded one or your preferred distribution isn't on the list.\*

VICE - v2.2. <a href="http://viceteam.org/">http://viceteam.org/</a>. Free GNU General Public License source code and executable by The VICE Team. VICE is a program that runs on

a Unix, MS-DOS, Win32, OS/2, Acorn RISC OS, BeOS, QNX 4.x, QNX 6.x, Amiga, GP2X, Dingoo, Syllable, SkyOS or Mac OS X machine and executes programs intended for the old 8-bit computers. The current version emulates the C64, the C64DTV, the C128, the VIC20, almost all PET models, the PLUS4 and the CBM-II (aka C610). VICE requires access to the original Commodore ROMs.

Kernel Source - v2.6.33. <a href="http://www.kernel.org/">http://www.kernel.org/</a>. Free GNU Public License source code for all platforms by the Linux community.

## Sony Update Removes OtherOS Feature from PS3

Thanks to Paul Howard for bringing this news to my attention.

On April 1st, Sony Computer Entertainment, Inc. released a firmware update for the Sony PlayStation 3 (PS3) entertainment system that disabled the "OtherOS" feature on the original "FAT" models of the PS3. OtherOS allowed the installation of GNU/Linux operating systems in addition to the native "GameOS" on the PS3 (the OtherOS feature is not included in the current "Slim" model PS3). Sony's announcement on the PlayStation blog (<a href="http://blog.us.playstation.com/2010/03/28/ps3-firmware-v3-21-update/">http://blog.us.playstation.com/2010/03/28/ps3-firmware-v3-21-update/</a>) states that this feature was removed "due to security concerns." Sony warns users of the OtherOS feature to backup their files onto external media before applying the update.

The community consensus is that the "security concerns" result from the January announcement by well-known iPhone hacker George Hotz (aka Geohot) that he had cracked the security protections on the PS3 to gain access to PS3 system memory and processors (<a href="http://geohotps3.blogspot.com/2010/01/hello-hypervisor-im-geohot.html">http://geohotps3.blogspot.com/2010/01/hello-hypervisor-im-geohot.html</a>). Geohot followed up on his blog by publishing the exploit, which he found by using Ubuntu Linux under the OtherOS feature. Sony apparently believes this exploit can be used to compromise the system to pirate games or services.

While PS3 users are not forced to accept and install the firmware update, Sony warned that refusing to do so would, among other things, prevent access to the PlayStation Network required for online multiplayer games, downloadable content (games, game demos,

game updates, themes, video) and the PlayStation Home online community. This also prevents future functionality updates, including PS3 support for 3D BluRay discs expected later this year.

Admittedly, few PS3 users take advantage of the OtherOS feature, but I am one of them, and I am not happy that Sony is removing an advertised feature that was one of its major selling points for me, and something that I demonstrated at WAC meetings. Even PS3 owners who don't use the OtherOS feature expressed their concern and anger on the official PlayStation 3 blog that Sony is setting a very bad precedent by forcing removal of established features with an update. While the Sony PS3 End User License Agreement (EULA) allows this, the legality is still being debated.

On April 1st, I received notice on my (Internet connected) PS3 that the update was available for download. I refused to install it, but, as Sony warned, my PS3 refuses to connect to the PlayStation Network until the update is installed. However, for the moment, my Netflix Internet streaming video access continues to work on the PS3.

Its also worth noting that Geohot posted on his blog that he advises users not to install the firmware update while he investigates modifying the PS3 firmware update to retain the OtherOS feature without disabling PlayStation Network access.







## Deleting a Hyperlink

Part of Microsoft Excel's compatibility with the Web is to allow you to define hyperlinks in your workbooks. There may come a time when you no longer need a particular hyperlink. Fortunately, deleting a hyperlink in Excel is very easy to do. All you need to do is follow these steps:

- 1. Right-click on the hyperlink. Excel displays a Context menu.
- 2. Choose the Hyperlink option from the Context menu. Excel displays a submenu.
- 3. Choose Remove Hyperlink from the submenu. Excel dutifully removes the hyperlink.

You should note that in some versions of Excel (such Excel 2003 and Excel 2007) there is a Remove Hyperlink option directly on the Context menu displayed in step 1. If this is the case, consider yourself fortunate—you can directly remove the hyperlink without the extra steps.

Don't make the mistake of thinking that you can get rid of a hyperlink simply by clearing a cell (moving to the cell and pressing Del). You can do this in the newer versions of Excel, but you cannot in the older versions. If you do this, the hyperlink text is gone, but the hyperlink itself is still lurking in the background. If you type some information in the cell again, you will notice it is underlined, indicating it is still a hyperlink. The reason for this is because Excel considers the hyperlink to be a format of the cell. Pressing Del only clears the contents of the cell, not its format. You can use other editing techniques to get rid of a hyperlink, however, provided those techniques result in getting rid of formatting or overwriting the formatting.

## Mixing Column Formats On a Page

It is not uncommon to have a document that mixes different column layouts on a single page. For instance, let's assume you have a five-page document, and you want to format the center part of page two as three columns. You want the rest of the document to remain a single column. To overcome this formatting challenge, you can follow these steps if you are using Word 97 through Word 2003:


- 1. Select the text that will appear in the columns.
- 2. Choose the Columns option from the Format menu. Word displays the Columns dialog box.
- 3. In the Number of Columns field, specify the number of columns you desire.
- 4. In the Apply To box, make sure it says Selected Text.
- 5. Click on OK. Word places the selected text into its own section and sets it in the number of columns you specified.

If you are using Word 2007, then the steps are a bit different:

- 1. Select the text that will appear in the columns.
- 2. Choose the Page Layout tab for the ribbon.
- 3. In the Page Setup group, click the Columns drop-down list.
- 4. Pick the number of columns you want to use for the selected text.

## Nybbles and Bits

ast month, I mentioned an article in TechRepublic regarding removing old drivers from your system. Little did I know that issue was going surface in my notebook computer that I upgraded to Win 7. The touchpad on my notebook computer has a vertical scroll area at the right side of the pad. I had no problems using the vertical scroll until I upgraded to Win 7 at which point, it stopped working.

I ignored the problem until just after the January PPCompAS meeting. When I started to investigate and tried to access the settings for the touchpad, there was a pop-up dialogue box telling me that IntelliPoint was blocked from running because of known incompatibilities with Win 7. It took me a few minutes to remember that I had bought a USB mouse and installed Microsoft IntelliPoint software shortly after purchasing the notebook. I had used the USB mouse until I bought a Logitech wireless mouse a year or so ago.

My first thought was to just remove the offending software. Good idea except there was nothing shown for IntelliPoint in the Programs and Features list and nothing for the USB mouse in the Mice section of Device Manager. Connecting the USB mouse made it appear in Device Manager and caused IntelliPoint to appear in the Programs list. I thought I was close to being done. Surprise, surprise! Trying to perform an uninstall of the software produced the pop-up about IntelliPoint being blocked. I wondered how you could uninstall it if it was blocked from running. This time the pop-up dialogue box provided a link to an update and I performed the update. After the IntelliPoint update completed, the vertical scroll on the touchpad worked correctly. However, I decided to remove IntelliPoint because I no longer use the USB mouse and could not think of a good reason to leave the software installed.

This is the first time I can remember where it was necessary to upgrade software just to remove it. I expect the Win 7 upgrade did not upgrade the IntelliPoint software because the USB mouse was not connected at the time the upgrade was performed.

Maybe next time I will remember that USB devices should be plugged in during an upgrade and to make the related software and drivers visible. Even better would be to remove old drivers as TechRepublic suggests.



## Improve PC Performance With TuneUp Utilities 2010

any of us seem to be in a perennial battle to improve the performance of our computers, trying to tweak out the last little bits of performance that our machines are capable of. I am always searching for ideas and utilities that can provide that last little bit of performance improvement, and have tried literally dozens of software products that claim to improve performance. While most do work well, there are always a few that do not. Recently, I downloaded a copy of TuneUp Utilities 2010 hoping to squeeze that last bit of speed out of my Windows 7 computer, and it appears to work very well, as advertised!

I went to www.tune-up.com and downloaded the free, fully functional 30 day trial. It downloaded quickly, and installed smoothly. The full retail price of the 2010 version is \$50, and for those with earlier versions (like me) the upgrade price was \$30. Checking my favorite price comparison website, Google's Froogle service (froogle.google.com), showed that the software is currently available from several online retailers at substantial discounts.

After opening the program, I was greeted with four windows marked "Maintain system", "Increase performance", "Fix problems", and "Customize Windows". The "Maintain system" shows a green check marked "Automatic" that by default (settings can be manually changed) will check the computer for problems every three days while the machine is idle. The automatic setting will optimize the system startup and shutdown, defragment the hard drive, remove broken shortcuts, and clean and defragment the registry. There is also an option for a "1-Click Maintenance" that will run the automated maintenance utilities whenever desired by the user.

In order to "Increase performance", TuneUp Utilities 2010 offers a real-time "live optimization", a turbo mode, a hard drive cleaner (removes useless files), configures the system startup for optimal performance, and offers to uninstall unneeded programs. The summary that was displayed indicated that I had four things that still needed to be optimized,

which included one recommended Firefox plug-in, and changing two Firefox settings; one visual effect should be turned off in order to improve my video performance. Implementing these recommendations should improve my Internet performance. TuneUp Utilities will automatically implement these recommendations if the user approves of the changes.

Under the heading "Fix problems", only one problem was detected on my computer, and that was the fact that I had not recently checked my hard drive for errors. The software incorporates a "TuneUp Disk Doctor" to detect and repair hard drive errors and related problems, which can be invoked with a mouse click. In addition to checking the hard drive for errors, the software will search for common problems, can restore deleted files, and manage running programs.

Many of us like to customize the way that Windows works and appears to us, rather than accept the program defaults. The "Customize Windows" feature allows the user to control the display, input options, start menu, task bar, network and browsers, email, personal privacy, user logons, clean the memory and cache, maintain the system startup, system security, and many other settings. The user need not be a geek in order to perform these tasks, as the options are clearly explained, and TuneUp Utilities will actually do the real work. Many users are afraid to make system changes, and have a concern that they may do something wrong and ruin their computers; the "Rescue Center", with a life-ring icon, can selectively undo any changes that were made, allowing any changes to be undone.

The four tune up boxes do not contain the only available functions, as there is a pull down menu labeled "More functions" that offers additional tools to the user. The user can get an optimization report, undo changes, check for software updates, show system information, and other functions. For those worried about securely deleting information, there is a Tune-Up Shredder which can securely delete files such that they would be very difficult to recover. For those who like to manually tweak the registry, an activity that I do not recommend unless the user is very aware of what he is doing and has backed up the registry prior to modifying it, there is a TuneUp Registry Editor which is much more feature rich than Windows inte-

gral "Regedit" registry editor.

While I have no empirical scientific evidence that TuneUp Utilities 2010 has actually improved my performance, I do have the perception that my Windows runs smoother, boots faster, shuts down quicker, and demonstrates better performance. I was happy with the results, and will continue to use the program.


TuneUp Utilities has been a popular utility, with over 10 million registered users since the first version was released in 2003. It runs well on modern versions of Windows starting with XP, and including Vista and the new Windows 7, in both 32 and 64bit builds.

I would suggest that users download the free, fully functional, 30 day trial version of TuneUp Utilities 2010 from www.tune-up.com/download, and put it through its paces. If it works as expected, then purchase it. I now have the full version and use it frequently to keep my computer performing up to its capacity. *Screen shots continue...* 









